### **Rent Supplement Calculations for Federal Co-ops**

The Ontario Community Housing Renewal Strategy contains some good news about rent-gear-to-income (RGI) calculations. We'll outline what remains the same, what is changing, and how recent details in the strategy might impact your work to calculate RGI subsidies.
